## Objective

Université Laval has expanded the exemption scholarship program offered by Ministère de l'Enseignement supérieur (MES). This exemption scholarship program is designed to attract the best doctoral students to Université Laval and better contribute to their academic success. **All international students who enroll full-time in a regular doctoral program at Université Laval will be eligible to pay the same low tuition fees as Québec students.**

## **Eligible applicants**

• International students

### Who it's for

- Doctoral students
  - All doctoral students

If you are admitted to a bachelor's or master's program you are not eligible for the Université Laval exemption program and your application will not be processed.

## **Eligibility criteria**

You must:

- Be admitted into a doctoral program at Université Laval
- Complete BBAF's online form (click **submit your application** on the upper right-hand side of the page)
- Have a study permit that complies with Canadian immigration regulations upon your arrival at Université Laval and study in Quebec
- Provide proof that you have applied for an exemption from your home country (only for applicants from countries that have signed an agreement with Québec see <u>list of countries</u> with agreements [in French])

#### Deadline

Please note that to be eligible, exemption application forms must be sent to the Student Awards and Financial Aid Office (BBAF) by the deadline shown below for each semester.

• Exemption for the 2022 summer semester: August 31, 2022

- Exemption for the 2022 fall semester: December 31, 2022
- Exemption for the 2023 winter semester: April 30, 2023

#### **Announcement of results**

We will contact selected applicants as soon as possible to notify them of the results of their application.

#### **Invoice adjustment**

Tuition fees for students granted this exemption will not be adjusted until after the deadline for complete or partial withdrawal from courses with a refund.

#### **Renewal procedure**

If your home country has signed an agreement with Québec and it offers doctoral scholarships, you must submit an application for exemption to your government every year to renew your scholarship. The Student Awards and Financial Aid Office will contact potentially eligible students every year by April.

#### **Distance Learning**

Due to the pandemic situation, Université Laval had granted certain accommodation measures by allowing distance studies in the last two years. However, starting in the 2022 summer semester, foreign students must have a valid study permit and be in Québec City to pursue their studies in order to be eligible for the payment of their scholarship.
